# The group has heroically rescued the iconic building, Gavin's Mill, for community use.

Milngavie, population now some 13,000, has been described as "the child of the Allander" because a series of water-dependent industries grew on the banks of the Allander Water, beginning with the corn mill. There has been a mill at this location since the time of King David (12<sup>th</sup> century), and it has been suggested that the name 'Milngavie' derives from 'Milndavie'. It is exceptional to find a mill building of this kind surviving to the present day in the centre of the town to which it gave birth. Gavin's Mill thus lies at the root of the town's identity.

Gavin's Mill has enjoyed a special place in the hearts and minds of Milngavie people for many years. When the town became a burgh in 1875, one of the people responsible was the miller, James Watt, who in 1876 became the burgh's second provost. When the mill was severely damaged by fire and demolition threatened during the 1960s, the efforts of a local architect to rebuild and revitalize it were greatly appreciated. Without such community concern the mill would probably have been lost completely to the 1970's by-pass construction. Recently a planning application threatening the setting of the building was successfully resisted by local people, after a long and hard-fought campaign.

Gavin's Mill Community Project (GMCP) is a SCIO established in January 2017 by East Dunbartonshire Fair Trade campaigners. With the closure of the Balmore Coach House in January 2017, GMCP saw an opportunity to develop Gavin's Mill as a centre for fair trade, heritage and community work. The group has restored the near-derelict mill within a remarkably short time. Using mainly volunteer labour, the project has repaired damage to the exterior and refurbished it inside and out so that it is now in use, not only as a fair-trade shop and café, but also as a meeting place for local groups. The kitchen has been refurbished so that soup and home-baking can be cooked by volunteers.

The rescue of this building is the first stage in an ambitious longer-term project. GMCP has successfully negotiated a lease from the owner, with an option to purchase the property after 3 years. The Project intends to raise sufficient funds to buy the Mill and some adjacent land in order to extend the facilities. The new facilities will include provision for exploring the history of the mill, its place in the development of local agriculture, and the parallels that exist between this history and current developments in farming in Africa. It will host heritage walks, generate sustainable energy and market locally-grown produce as well as provide flexible social spaces. It will help young people learn skills in food growing, cooking and catering.

#### Please describe the building/project (200 words)

Gavin's Mill is a B-listed former corn mill situated on the Allander Water in Milngavie's designated Town Centre, and, indeed, in the Town Centre Conservation Area. The existing building, dating in part from at least the 17<sup>th</sup> century, is built of stone and has slate roofs. It has undergone many changes over the years and now has the form of twin gables with a central gutter. Inside, besides the two main floors, there is an attic used as the office and a slightly lower mezzanine area adjoining the upper floor. The overshot mill wheel is still in place, but is not currently usable.

The corn mill was operational until the 1960s fire. Following restoration in the late 1960s, Gavin's Mill housed a popular café, an architect's office, some small shops and, for the last 20 – 25 years, Indian and Chinese restaurants. When the last of these restaurants closed around December 2014, having for some years been used solely for carry-out meals, the building was locked and abandoned.

When GMCP took on the tenancy, the interior was filthy and the exterior showing signs of dilapidation. The roof leaked and there was regular flooding at times of heavy rainfall.

#### Sharing

How did the 'angels' contribute to/benefit the project? What new skills have been learnt or shared? How has the project enhanced the knowledge/skills of volunteers? (Max 200 words)

GMCP volunteers have played a hugely important part in the project. They were entirely responsible for the management of the refurbishment, in particular the coordination of tradesmen and volunteers engaged in the refit. Volunteers were wholly responsible for cleaning, decorating, shop-fitting and restocking; and major works required in restoring external spaces.

Local historians provided an exhibition recounting the Mill's history; further interpretative media will feature as the Project develops.

Local gardening organisations have completely transformed the garden, over-run with non-native invasive species.

The new fair trade shop and café is run by a Board of volunteers and staffed almost entirely by volunteers who are rapidly learning the skills required, including baking and supply of soup. Volunteers continue to work on restoration of the building and grounds as well as on shop fitting and internal maintenance. Without such volunteer contribution, it would have been impossible to cover the initial start-up costs.

All of this was co-ordinated by GMCP, and financially underwritten by individuals and the Balmore Trust, who also provided an interest free-loan for the cost of initial stocks.

The new fair trade shop and café have already become popular with local people.

# *Need:* What was the need for the project? (Max 200 words

# The need for this project arose from the imminent closure of Balmore Coach House in the adjacent parish of Baldernock, which coincided with the Milngavie community's aspiration to rescue Gavin's Mill from dilapidation following disuse.

Balmore Coach House was one of the first UK Fair Trade shops and had provided support for the development work of the Balmore Trust (over £1 million in grants to local and overseas development projects). With closure of the Coach House due in January 2017, a new venue for the work which had been based there was urgently sought.

The potential for Gavin's Mill as a community and tourism asset for the town had been highlighted by Milngavie Heritage Centre in 2011.

In 2015, extensive community engagement by a subgroup of Milngavie Community Council (the precursor of Milngavie Community Development Trust), showed that the aspiration for rescue and community ownership of this building was widespread.

However, only with the extra-ordinary initiative and energy supplied by Gavin's Mill Community Project did a possible pathway become apparent towards the fulfilment of this long-standing aspiration. GMCP saw an opportunity to develop Gavin's Mill as a centre for fair trade, heritage and community work. Local community and heritage groups have given enthusiastic support to the project.

# Perseverance:

# What challenges had to be overcome? Did the project suffer any setbacks? (Max 200 words)

GMCP has had to contend with

- A collapsed ceiling, caused when an upstairs toilet cracked after being frozen during the winter 2016-17;
- Cleaning ingrained dirt from all areas. A small army of volunteers helped to clear rubbish and clean the entire building; many now help in the shop and cafe. Volunteers from Tesco removed the carpet from the main room, which had been the restaurant.
- Safety issues around the height of the main room a scaffold tower was needed for electrical and decorating work;
- Heating and drying out the interior, especially the ground floor café area which was uninviting particularly during the winter; the central heating has been overhauled and the building is gradually drying out and warming up.
- the need to maintain a dedicated and enthusiastic body of volunteers to staff all aspects of the work of the shop and café. 4 volunteers are required at any time, usually working for 3-4 hours a shift: some 48 volunteer shifts per week.
- Establishing good governance of the project as a whole.
- Ensuring good financial control
- Meeting all environmental health, data protection and care of vulnerable persons legislation.

# *Legacy:* How has the project contributed to the future of a heritage site/s and/or the sharing of knowledge and skills. (Max 200 words)

The project has prevented the deterioration of Gavin's Mill, which was in danger of falling into irrevocable disrepair. It has begun a new era in the life of the building, as a fair-trade shop and café in the first instance, but with ambitious plans for restoring the Mill as a centre for sustainable development, including working with the Milngavie Heritage Centre to explore and interpret the Mill for the local community and visitors as an important part of the local industrial heritage. Due to its location at the start of the West Highland Way, Milngavie receives visitors from all over the world.

The project has led to the formation of a mills research group, with members from Milngavie, Bearsden and Baldernock heritage groups, who have been carrying out intensive research into the history of Gavin's Mill and other mills in East Dunbartonshire. Relatives of the last miller and of the architect who restored the building after the fire were interviewed and photographs, drawings and historic items obtained. In March, Milngavie Heritage Centre mounted a week-long exhibition "The Mills of Milngavie and District" in the former courtroom of Milngavie Town Hall.
